## CITY OF HAMILTON

## BY-LAW NO. 09-042

## To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

**WHEREAS** Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Brucedale North from 29 feet west of ½ hr 9 am – 6 pm Mon – Sun" Upper James to 45 feet westerly

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Albany	South	Kenilworth to Harmony	Anytime
Beach Blvd.	East	from 9.1m south of Dynes Park Ave. to 88.1m northerly	Amytime
Brucedale	South	From 130 ft. west of Upper James to 56 ft. westerly	Anytime

and by adding to Section "E" thereof the following item, namely:

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"MacNab East From 17.2m north of MacAulay to Anytime" 5.5m northerly

and by adding to Section "E" thereof the following item, namely:

"Brucedale North from 37.5m west of Upper James to Anytime" West 2<sup>nd</sup>

- 5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

and by adding to Section "E" thereof the following item, namely:

"Erindale	East	Dundonald to 33.5m northerly	7:00 a.m. to 5:00 p.m."

- 6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
