## CITY OF HAMILTON

## **BY-LAW NO. 09-084**

## To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act:

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "A" thereof the following item, namelv:

"Londonderry Both Lowinger to east end 2 hr 8 am – 5 pm Mon – Fri" of Londonderry

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

"Londonderry Both Lowinger to east end of 7:00 a.m. - 4:30 p.m." Londonderry Monday to Friday

and by deleting from Section "E" thereof the following item, namely:

"Coronation Both Parkdale to easterly end 8:30 am - 5 pm" Mon - Fri

and by adding to Section "E" thereof the following items, namely:

"Coronation South Parkdale to easterly end 8:30 a.m. to 5:00 p.m. Monday to Friday
