BY-LAW NO. 09-097

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following item, namely:

"Grant Blvd. Both Bertram to north limit of Grant 9 a.m. – 5 p.m."

Blvd Mon. – Fri. Holidays Excepted

and by adding to Section "B" thereof the following item, namely:

"Grant Both Barrie to the north-easterly end 9:00 a.m. to 5:00 p.m."

of Grant Monday to Friday

and by deleting from Section "E" thereof the following item, namely:

"Duke South Commencing 69 feet west of Anytime"

James and extending to 1 point 22 feet westerly

therefrom

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

"Duke South from 27.4m west of James to Anytime" 7.3m westerly

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Avondale East from 31.4m north of Beechwood to Anytime 6.2m northerly

Avondale West from 35m north of Beechwood to Anytime" 5.7m northerly

and by adding to Section "E" thereof the following items, namely:

"Avondale West from 78.6m south of Barton to 6.1m Anytime southerly Fairleigh West from 38.5m south of Wilson to 6.5m **Anytime** southerly Glenside Both Chedoke to 47.3m westerly **Anytime** Anytime" Grosvenor East from 52.6m north of Dunsmure to 4.9m northerly

3. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Kinrade West from 147.9m south of Barton 8:00 a.m. to 5:00 p.m." to 6.6m southerly Monday to Friday

4. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Harvest North from 49m east of Short to 61m 7:00 a.m. to 6:00 p.m."
easterly Monday to Saturday

- 5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 6. This By-law shall come into force and take effect on the date of its passing and enactment.
