CITY OF HAMILTON

BY-LAW NO. 09- 213

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Cyprus	West	from 30.1m north of Dolphin to 9.3m northerly	Anytime
James	West	from 50.8m north of Mulberry to 10.9m northerly	8:00 a.m. to 9:00 p.m. Monday to Saturday
Market	South	Ray to Queen	7:00 a.m. to 6:00 p.m. Monday to Friday
Ray	West	6m south of Market to 6m north of Market	Anytime
Ray	West	King to Market	7:00 a.m. to 6:00 p.m." Monday to Friday

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

“James West from 56.7m north of Mulberry to 12.4m northerly Anytime”

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

“Gordon South from 70.2m east of Cavell to 6.1m easterly Anytime”

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

“Picton North Catharine to 16m westerly Anytime”


4. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

“Picton North from 16m west of Catharine to 18.7m westerly 7:00 a.m. to 6:00 p.m. Monday to Saturday

Picton North from 37.2m east of John to 19m easterly 7:00 a.m. to 6:00 p.m. Monday to Saturday”

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
