**CITY OF HAMILTON**

**BY-LAW NO. 10-248**

**To Amend By-law No. 01-218, as amended,  
Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Britannia      North      Archibald to Harmony      2 hr      Anytime      Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following items, namely:

"Sullivan's      East      from 148.6m south of Ann to southerly end      Anytime

Sullivan's      West      from 140.7m south of Ann to southerly end      Anytime

York Rd.      East      York Rd. to King St.      Anytime"

and by adding to Section "B" thereof the following item, namely:

"York      East      from 107m north of King to Cairns      Anytime"

and by adding to Section "E" thereof the following item, namely:

"Dundurn	West	Stanley to 38.3m southerly	7:00 a.m. to 5:00 p.m." Monday to Friday
----------	------	----------------------------	---

and by adding to Section "F" thereof the following items, namely:

"Meadow Wood	West & North	from 23.4m south of the eastern intersection with Old Mud to 28.8m southerly and westerly along the curb line	Anytime

Village Green	North	from 5.7m east of westerly end of Village Green to 6m easterly	Anytime"

and by adding to Section "G" (Loading Zones) thereof the following item,  
namely:

"York	East	from 93.6m north of King to 13.4m northerly	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Britannia	North	from a point 40 feet east of Archibald to Harmony	Anytime

East 8 <sup>th</sup>	East	commencing 396 feet south of Queensdale and extending 22 feet southerly therefrom	Anytime
----------------------	------	---	---------

Markland	North	commencing at a point 65 feet east of the east curb line of Bruce to a point 22 feet easterly therefrom	Anytime"

and by adding to Section "E" thereof the following item, namely:

"Britannia	North	from 5.9m west of Harmony to 13.9m westerly	Anytime"

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:


"Lloyd                      South      from 46m east of Lottridge to      7:00 a.m. to 5:00 p.m."  
5.5m easterly


and by adding to Section "E" thereof the following item, namely:

"Shelby                      East      from 15.7m south of Melvin to      Anytime"  
7m southerly

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
